The meeting was held in conjunction with the Annual Reception, and a number of staff and guests were present.

1. Call to Order

Chair Anthony Sun called the meeting to order at 5:12 p.m., a quorum being present. He welcomed everyone, including representatives from the museum's auxiliary groups that include the Alumni Board, AAM Council, Connoisseurs' Council, Docent Council, Korean Art and Culture Committee, Society for Asian Art, Storytellers, the Volunteer Programs Corp, and other special guests. He acknowledged Commissioners and Trustees who transitioned to the Alumni Society within the past fiscal year: Bob Ackerman, Chris Dupuy, Pamela Joyner, Phyllis Kempner, Michael Kim, Kevin McCabe, Glenn Ramsdell, Doug Tilden, Susy Wadsworth, Doris M. Ward.

2. Approval of Minutes

Minutes from the June 24, 2014 meeting approved as written.

3. Chair's Report and Consideration

Following a video that reviewed highlights of museum events and activities for the year, Tony introduced Akiko Yamazaki and called for the Commission's approval of its new slate of officers: Chair Akiko Yamazaki, Vice Chairs Timothy F. Kahn and Judith F. Wilbur, Secretary James D. Marver and Treasurer Anthony Sun.

4. Chair Akiko Yamazaki

As a symbolic gesture of passing along the gavel, Anthony Sun presented Akiko Yamazaki with a ruyi scepter—a Chinese talisman for power and good fortune. In her inaugural address as Chair, Akiko paid tribute to a challenge Tony made during the June board meeting when he asked us to dare to be great—to dare to do the things necessary to be great. Akiko said she wants to lead us in taking that challenge and talked about what it means to be great: We have a magnificent collection in a great city, a wonderful building, a strong staff and director, a committed board, a wonderful group of supporters, and we know <u>it is for the visitor</u>—the visitor's experience—that we need to dare to do what is necessary to be great. Starting with the 2007 Strategic Directions Plan, Akiko reviewed a timeline of the museum's continuous path of building blocks achieved during the journey that led us to the adoption of the 2013 Business Plan. Akiko expressed assurance that we can confidently accept the challenge to dare to make the tough decisions necessary to be great. She asked us not just to dare to be a great Asian art museum, she asked us to dare to be a great museum. She invited everyone to join us in our efforts. In her first action as Chair, Akiko called for the approval of Anthony Sun as Chair Emeritus and presented him with a token of appreciation on behalf of the board and staff.

5. Art Hit

Akiko Yamazaki introduced Senior Curator of South and Southeast Asian Art Forrest McGill who gave a presentation on new acquisitions.

6. Finance Report

Treasurer Timothy F. Kahn gave a brief report on 2014, reviewing Key Performance Indicators and operating results, and the 2015 budget looking at contributed revenue, expenses, comparatives to FYs 13 and 14, and investments.

7. Director's Report

Director Jay Xu's report focused on impact demonstrated through leadership (within the industry, by staff and board); engagement (how effective we are in encouraging dialogue and interaction with visitors); reach (reaching visitors in our galleries, the international terminal at SFO, through external partners in education or other institutions where our exhibitions travel, online, through social media); relevance (sparking connections and making Asian art and culture relevant to people's lives); and support. He noted that none of what the museum does would be possible without the generosity of supporters, and that the museum is grateful to everyone who believes in the museum's mission and helps to support it with their contributions.

8. 50th Anniversary Committee Report and Oral History Project Celebration

With the museum's 50th Anniversary approaching in 2016, board members David Lei and Judy Wilbur (co-chairs of the 50th anniversary committee) joined forces to share plans for celebrating and supporting the museum at this important milestone. It was noted that an

essential aspect of celebrating 50 years would be to capture the museum's history. Judy Wilbur announced completion of three compelling interviews as part of the museum's Oral History Project – interviews conducted by UC Berkeley's Regional Oral History Office – and presented bound copies to interviewees: Founding and Current Commissioner Alexander Calhoun and his wife Connie, Former Commissioner Alice Lowe and Curator Emeritus Terese Bartholomew, with grateful appreciation on behalf of the museum.
