1. Call to Order.

Chair Akiko Yamazaki called the meeting to order at 4:05 p.m., a quorum being present.

2. Approval of Minutes

Minutes from the July 17, 2018 Special Meeting were approved as written.

3. Transformation Project Report

Foundation Transformation Project Committee Chair Tim Kahn gave a quick technical update, noting positive support from the City in recent weeks. He said gallery permit was complete and that had allowed the third floor galleries to be closed for renovation with a projected reopening in the first quarter of 2019. He said the second floor galleries would close around March, reopening later in the year to take advantage of lighting replacement installation to be paid for by the City. Tim reported successful meetings with the Mayor's Office of Disability regarding the last step before receiving the pavilion permit and that final inspections for construction would be done after the permit is complete. Tim closed, noting signage permits were moving along as well.

Foundation Campaign Executive Committee Chair Akiko Yamazaki announced new campaign commitments since last reported on June 12 totaling \$4,147,500 bringing the total raised to date to \$87,176,451, reflected in the three buckets as: (i) Packages Funds: \$23.3 million; (ii) Facilities Funds: \$41.9 million; and (iii) Endowment Funds: \$21.9 million. She noted that fundraising toward the community phase goal continued as the museum prepared to launch its public community campaign, noting the Campaign Executive Committee had set an internal goal of \$1,000,000 toward the initiative and that to date, the community phase, including gifts under \$100,000 starting in FY18, had raised \$294K. She said gifts to the community campaign were reflected in all three fundraising buckets previously mentioned.

4. Operations Report

Chief Philanthropy Officer Nancy Sackson presented new initiatives being launched to help increase contributed revenue, to be centered around the excitement of opening the pavilion and the fact that more money is needed to fund the operation of the new building. She said one of the first things being done was to work with Development Committee Chair Fred Levin to reconfigure the Development Committee to a smaller group composed of representatives from each of the museum's funding constituencies, such as Nexus and Jade, as well as from the corporate community, to meet three times per year to help guide and execute the museum's fundraising plans, paying particular attention to increasing support for special exhibitions. Another is a Silicon Valley initiative to engage audiences through a dynamic series of pop-up events and family programs in Silicon Valley and on the peninsula. Next, Nancy talked about an Exhibitions Focus initiative to develop and implement a strategy for special exhibition fundraising focused on multi-year support of the museum's pipeline. with a more integrated approach to special exhibition fundraising. Nancy reviewed the final initiative, thanking Trustee Kapil Chhibber, which is to work with the Bay Area Alumni group of Harvard Business School on a project to define a higher-impact approach to moving top corporate donors through the pipeline, with an end result being an outline of best practices to engage potential corporate donors, particularly Asia multi-nationals, Nancy also announced the launch of a pilot project to explore and model the viability of an international program of AAM affiliate support groups in major Asian cities: Friends of the Asian Art Museum. In closing, Nancy reminded everyone that board giving increased from \$25,000 to \$50,000 per year effective FY19.

Chief Operating Officer Joanne Chou presented a high-level overview of fiscal year 2018 results, noting special exhibitions *Flower Power*, *Couture Korea*, and *Divine Bodies* guided activities for the fiscal year. She reviewed revenue (contributed, earned, other), special revenue and operating expenses overall and by division, noting during the transformation period the museum expects revenues to exceed normal operating expenses and will use special revenue from the campaign and board reserves to balance the annual budget.

Director and CEO Jay Xu presented the Director's Report highlighting activity since the June full board meeting, activity on the horizon, and administrative developments and planning. He noted with congratulations the inauguration of Mayor London Breed on July 11 and that she would attend the annual meeting celebration in the early evening. He reported his attendance at two major Director's

Conferences in Asia associated with Tales of the Phoenix Land exhibition, scheduled to be the second exhibition in the Pavilion, and his attendance at the Suzhou Museum for the opening of Masters of Bamboo, drawn from our Cotsen collection and the first Asian Art Museum exhibition to exhibit in China. Jay surveyed Art & Programs Division activities featuring publication of the new Collection Highlights, summer exhibitions (Divine Bodies, Testimony, and Guided Tour of Hell) and just opened exhibitions (Painting is my Everything and Haroon Mirza: Night Journey). He noted a changing of the guard, so to speak, to the museum's popular front steps public sculpture series at Osher Plaza: removal of *Dragon Fortune* (aka Happy Dragon) soon to be replaced by *Your Dog* by neo-pop artist Yoshitomo Nara. Jay highlighted fantastic Thursday night programming including the cutting-edge Tasting Menu series, and third floor gallery closing for transformative reinstallation of the Masterpieces. Jay described a new division and leadership position on the horizon – Division: Marketing & Communications; Position: Chief Marketing & Communications Officer (CMCO). Jay discussed the re-tooling of the strategic planning cycle to foundationally inform the Strategic Plan for the transformed museum: (i) development of institutional priorities every October by the staff Executive Team (followed by consultation with board leadership), (ii) middle management production of concrete initiatives for the next fiscal year, and (iii) January annual budgeting process. He introduced staff members Zac Rose and co-presenters Chuck Etheridge and Karin Oen who reviewed the work of staff Vision Boards 2.0A and 2.0B, respectively, noting the work of 2.0A was to determine how to implement the REINA values to transform the institutional culture, morale, and communication, and 2.0B was to transform the visitor experience).

Ms. Yamazaki reported on the capital campaign and welcomed new members of the 70-member strong Avery Brundage Founders Circle. A special highlight was the announcement of a generous contribution by East West Bank for the East West Bank Art Terrace. Director Jay Xu thoroughly reviewed all aspects of what to expect in the transformed museum and Foundation Transformation Project Committee Chair Timothy Kahn reported on the construction side of the project, thanking fellow committee members for their hard work and dedication. Before adjournment and the fanfare of a groundbreaking ceremony, Ms. Yamazaki and Ms. Sun thanked everyone for their investment in the museum's future and their commitment to the museum's work, thanking all donors and expressing gratitude to the museum's docents, storytellers, volunteers, current and former staff, and for their fellow board members. Members of the public were invited to address the Commission on items within the subject matter jurisdiction of the Asian Art Commission. No members of the public present requested to make comments and the meeting was adjourned at 6:45pm.
