1. Call to Order

Chair Anthony Sun called the meeting to order at 4:00 pm. Tony commented on the energy and excitement at the Maharaja Gala October 19.

2. Approval of Minutes

Minutes from the April 25, 2011 Executive Committee and June 28, 2011 Special Executive Committee meeting were approved.

3. Art Hit

Associate Curator of South Asian Art Qamar Adamjee gave the art hit – Maharaja: The Splendor of India's Royal Courts.

4. Director's Report

Director Jay Xu's presentation surveyed highlights since the September annual meeting. In addition to highlighting *Maharaja* festivities, Jay covered projects in the works including (i) the museum's engagement of a Boston-based management consulting firm, TDC Management Consulting, to conduct a review of the museum's operations, charitable gift development, and governance, and to provide written recommendations for improvements; (ii) a comprehensive technology assessment of the museum's IT infrastructure under the leadership of an ad-hoc Foundation Technology Committee chaired by Trustee Steven Kahng; (iii) a capital campaign planning study under the guidance of capital campaign fundraising consulting firm CCS to raise at least \$20 million over three years as a measure to boost our endowment; (iv) a Budget and Legislative Analyst Performance Audit of Governance and City Oversight conducted for the

Asian Art Museum, the Fine Arts Museum, War Memorial and the Academy of Sciences, and (v) the San Francisco Asian Art Forum for Museum Directors convening November 8 and 9. Jay introduced Miriam Droller of CSS who was in attendance that day.

5. Finance Report

Newly elected Treasurer Tim Kahn gave opening remarks before calling on CFO/COO Mark McLoughlin. Tim noted in particular that the museum was able to bring the last year in on break even by using a portion of the remaining reserve board surplus that was set up in the last surplus year and that a priority should be to permanently increase revenue levels both earned and not earned. Mark McLoughlin reviewed finals for 2011, the current state of the forecast for 2012, and he showed reconciliation of revenue and expenses for 2011 and 2012.
